Officer Crumpton will participate in the torch run as he has done in previous years. He helps raise money for Special Olympics by selling t-shirts. Shirts are twelve dollars each. Chief Walker also reported the new generator is now working at the Public Safety Center.

Public Works Director Jeff Holliyan reported the paving of Fieldstown Road is now in progress.


