

**GARDENDALE, ALABAMA
CITY COUNCIL MEETING
FEBRUARY 7, 2011**

The City Council of the City of Gardendale, Alabama, met in a regular meeting on the 7th day of February, 2011, at 6:00 p.m., at the Gardendale City Hall. Mayor Othell Phillips called the meeting to order. Police Chief Mike Walker led the Pledge of Allegiance. Junior city council members Jacob Maynard and Jason Guthrie delivered the devotional and led the prayer.

City Clerk Keith Mosley was present and served as clerk.

MINUTES

The council was presented with a copy of the minutes of the regular council meeting held on January 17, 2011. Councilor Tumlin made a motion to approve the minutes as presented. The motion was seconded by Councilor Currington and carried by unanimous consent of the council members.

CORRESPONDENCE

Mayor Phillips read a card from a Library employee who thanked Library director Connie Smith for her support following the employee's recent surgery.

BILLS

Councilor Currington made a motion to approve payment of the February 7 bill list, as listed on "Exhibit A," which is attached hereto and made a part of these minutes. The motion was seconded by Councilor Harper and carried by unanimous consent of the council members.

COUNCILORS' REPORTS

Councilor Currington commended the Parks & Recreation employees for the improvements they have made at the Miracle League field and encouraged the citizens to visit the field. He also commended the civic organizations and corporate sponsors that have contributed to this project.

Councilor Phillips commended the Public Works employees for their work to keep the roads clear following the snow and sleet events that occurred recently.

Civic Center director John Brigham made reference to a schedule of upcoming Civic Center events that he had given to the mayor and council members previously.

Parks & Recreation superintendent Stan Hogeland reported the following: (a) Registration for the spring youth sports is almost complete. (b) The improvements that are being made at the Miracle League field are on course to be completed before opening day of the Miracle League season.

OLD BUSINESS

RE-BID FOR PAVING STREETS IN THE LEXINGTON PARK SUBDIVISION. Mayor Phillips stated that there was some confusion regarding the scope of work when this project was bid recently. He called on Public Works director Jeff Holliyan for additional comments. Mr. Holliyan said there was an option that the City wants to make available to all bidders, specifically that the City would purchase the materials at a pre-bid price through the Alabama Department of Transportation along with some minor changes to the scope of work. Councilor Phillips asked how long the paving project would take. Mr. Holliyan said the City has asked for a 90-day completion deadline. Councilor Harper then made a motion to solicit bids for paving the streets in the Lexington Park subdivision. The motion was seconded by Councilor Currington. There was no more discussion. The motion carried by unanimous consent of the council members.

NEW BUSINESS

PROCLAMATION: CAREER AND TECHNICAL EDUCATION MONTH. Councilor Tumlin read a proclamation for the month of February as "Career and Technical Education Month" in the City of Gardendale. Career tech students Blake Gwen and Lauren Hall were present to receive the proclamation from Mayor Phillips.

ORDINANCES

ORDINANCE NO. 2011-01: TO AUTHORIZE SERIES 2011 GENERAL OBLIGATION WARRANTS IN THE PRINCIPAL AMOUNT OF \$2,640,000 TO REFUND THE SERIES 1998 (CIVIC CENTER) GENERAL OBLIGATION WARRANTS. Mayor Phillips said the Series 2011 warrants will refinance the Civic Center bond issue at a lower interest rate, but with the same payoff schedule, which will produce a savings of almost \$135,000. He called on Reid Cavnar with Merchant Capital, LLC, the investment banking firm handling the warrants, for additional comments. Mr. Cavnar said the City received a AA- credit rating from Standard & Poor's which, he said, is an elite credit rating among Alabama cities. He cited the City's strong balances and low debt burden as two of the primary factors for this excellent rating which enabled the warrants to qualify for a low interest rate. He added there aren't many cities in Alabama with a credit rating of AA- or better. Mayor Phillips said the interest rate on this bond issue is 2.58%.

There being no more discussion, Mayor Phillips then called the roll of council members for the purpose of obtaining unanimous consent for immediate consideration of the proposed ordinance and recorded the following votes:

Councilor Currington then made a motion for adoption of Ordinance No. 2011-01. The motion was seconded by Councilor Harper. There being no more discussion, the motion then carried by unanimous consent of the council members.

RESOLUTION NO. 2011-03: TO CREATE A "BUSINESS/ECONOMIC DEVELOPMENT COMMITTEE." Councilor Harper introduced and made a motion for adoption of Resolution No. 2011-03. The motion was seconded by Councilor Currington. There was no discussion. The motion then carried by unanimous consent of the council members.

RESOLUTION NO. 2011-04: TO APPOINT MEMBERS TO THE "BUSINESS/ECONOMIC DEVELOPMENT COMMITTEE." Councilor Harper introduced and made a motion for adoption of Resolution No. 2011-04. The motion was seconded by Councilor Tumlin. There was no discussion. The motion then carried by unanimous consent of the council members.

RESOLUTION NO. 2011-05: TO CREATE AN ADMINISTRATIVE ASSISTANT II POSITION IN THE ADMINISTRATIVE DEPARTMENT AND PROMOTE PAM SHARBONO TO SAID POSITION; TO CREATE A SENIOR REVENUE EXAMINER POSITION IN THE ADMINISTRATIVE DEPARTMENT. Councilor Currington introduced and made a motion for adoption of Resolution No. 2011-05. The motion was seconded by Councilor Morris. Mayor Phillips called on City Clerk Keith Mosley who introduced Mrs. Sharbono who was in attendance. He commended her for her excellent service to the City and for this promotion. There being no more discussion, the motion then carried by unanimous consent of the council members.

RESOLUTION NO. 2011-06: TO RENEW AND EXTEND THE EMPLOYMENT AGREEMENT WITH TAX EXAMINER JAY BROWN. Councilor Currington introduced and made a motion for adoption of Resolution No. 2011-06. The motion was seconded by Councilor Harper. There was no discussion. The motion then carried by unanimous consent of the council members.

RESOLUTION NO. 2011-07: TO HIRE KELSEY DODD AS A CONTROL DESK CLERK AT THE CIVIC CENTER. Councilor Morris introduced and made a motion for adoption of Resolution No. 2011-07. The motion was seconded by Councilor Tumlin. There was no discussion. The motion then carried by unanimous consent of the council members. Civic Center director John Brigham introduced Ms. Dodd who was in attendance.

RESOLUTION NO. 2011-08: TO ACCEPT A BID FROM, AND AUTHORIZE A CONTRACT WITH, RICHARDSON CONSTRUCTION COMPANY, INC., FOR EXPANSION AND RENOVATION OF THE GARDENDALE-MARTHA MOORE PUBLIC LIBRARY. Councilor Tumlin introduced and made a motion for adoption of Resolution No. 2011-08. The motion was seconded by Councilor Morris. Mayor Phillips stated that ten companies submitted bids on this project, and most of the bids were in the range of \$1.2 million to \$1.3 million, although the highest bid was \$1.85 million. He stated that Richardson Construction Company has met all the standards contained in the bid requirements and added that the company's general contractor's

license number with the State of Alabama is No. 1. The motion then carried by unanimous consent of the council members.


CITIZENS' COMMUNICATIONS

ADJOURNMENT


