The City Council of the City of Gardendale, Alabama, met in a regular meeting on the 5th day of December, 2011, at 6:00 p.m., at the Gardendale City Hall. DEPARTMENT HEADS' REPORTS

Parks & Recreation director Stan Hogeland reported the following: (a) Celeste Lachenmeyer with Engineering Service Associates, Inc., has informed him that Veterans Landscaping Company has been awarded the low bid for the proposed Newcastle Park playground project. He said work is scheduled to begin in mid-January 2012, and the projected completion timeline is 120 days. (b) Keith Magee with Barge, Waggoner, Sumner, & Cannon, Inc., has informed him that they are 85% complete on the Parks & Recreation master plan. He said the plan will be ready for presentation in January 2012.

NEW BUSINESS

**SOLICITATION OF BIDS FOR A HEART MONITOR/DEFIBRILLATOR FOR USE BY THE FIRE DEPARTMENT.** Councilor Harper reported that Fire Chief Clint Doss has informed the council that one of the department's heart monitor/defibrillators is in need of replacement and that it is therefore necessary to invite bids for one. Chief Doss recommended that the bids should be returned in time to be opened during the next council meeting on December 19. Mayor Phillips said the bid specifications are available from the city clerk and from the fire chief. Councilor Harper made a motion to invite bids for a heart monitor/defibrillator as recommended by Chief Doss. The motion was seconded by Councilor Phillips and carried by unanimous consent of the council members.

**RE-SCHEDULING OF THE JANUARY 2, 2012, COUNCIL MEETING.** Due to a City holiday on January 2, 2012, Councilor Morris made a motion for the council meeting regularly scheduled for that day to be re-scheduled to the following day, January 3, at 6:00 p.m. The motion was seconded by Councilor Currington and carried by unanimous consent of the council members.

ORDINANCES

**ORDINANCE NO. 2011-15: TO AMEND ORDINANCE 2007-16, *THE BUSINESS LICENSE CODE OF THE CITY OF GARDENDALE*.** Mayor Phillips introduced Ordinance No. 2011-15 and stated that one of the primary purposes of the ordinance is to add several business license classifications for different types of businesses that currently are not included in the City's license code. Councilor Currington then made a motion for immediate consideration of the ordinance. The motion was seconded by Councilor Harper. Mayor Phillips then called the roll of the council members for the purpose of obtaining unanimous consent to consider the proposed ordinance and recorded the following votes:

Councilor Currington then made a motion for adoption of the ordinance. The motion was seconded by Councilor Harper. There being no more discussion, the ordinance was then adopted by unanimous consent of the council members.

### RESOLUTIONS

**RESOLUTION NO. 2011-66: TO AUTHORIZE LENDING OF CREDIT, EXPENDITURE OF PUBLIC FUNDS AND ISSUANCE OF GENERAL OBLIGATION TAXABLE WARRANT, SERIES 2011.** Councilor Currington introduced Resolution No. 2011-66 and made a motion for immediate consideration of the resolution. The motion was seconded by Councilor Harper. Mayor Phillips then called the roll of the council members for the purpose of obtaining unanimous consent to consider the proposed resolution and recorded the following votes:

Councilor Currington then made a motion for adoption of the resolution. The motion was seconded by Councilor Harper.

Mayor Phillips stated that this is a public hearing on this matter and asked if any of the audience members wished to speak about the proposed resolution.

Mr. Andrew Kinnaird, 4949 Brentwood Drive, asked for an explanation of the primary purpose and details of the proposed warrant issue. Mayor Phillips explained that the developer/owner of the subject shopping center (Northgate Village, located on Fieldstown Road near Odum Road) is going to totally renovate the center; a Publix supermarket will locate in the center; there is a gap between the cost of the renovations and the amount of bank financing for which the owner has received approval; and this warrant will enable the City to lend the necessary funds to the owner in order to fund the renovations. He emphasized that this will be a loan, not an outright grant of funds, to the owner. He said the City will take a second mortgage on the property, and the loan will be secured by a personal guaranty of the owner of the company. He added that the City will receive tax revenue from the new businesses that will locate in the center. In response to questions from Mr. Kinnaird about the risk that the City will incur, Mr. Paul Woodall, bond counsel, said Aliant Bank will make a loan of about \$12 million versus the City's loan of \$2.85 million and that the City will hold a lien on the property. In response to questions from Mr. Kinnaird about whether the City will charge interest on the loan and, if so, whether the City will make a profit on the loan, Mr. Woodall said the interest rate will be equal to the interest rate the City will pay Regions Bank on the warrant issue that will fund the loan, thus creating a flow-through of interest. Mayor Phillips added that the City is lending the money simply to enable the shopping center owner to undertake the renovations that will make it possible for new businesses to locate in the center and isn't necessarily desiring to profit from making the loan. Mr. Woodall also said the loan to the developer/owner will not close until Publix and T.J. Maxx have signed binding commitments to locate in the shopping center.

Mayor Phillips asked if there were any more comments or questions; there was no reply.

There being no more discussion, the resolution was then adopted by unanimous consent of the council members.

**RESOLUTION NO. 2011-67: TO AUTHORIZE A NEW STREET LIGHT ON MITZY DRIVE.** Councilor Phillips introduced and made a motion for adoption of Resolution No. 2011-67. The motion was seconded by Councilor Tumlin. There was no discussion. The motion carried by unanimous consent of the council members.

RESOLUTION NO. 2011-68: TO REVISE THE RATE OF PAY OF PART-TIME LIBRARY PAGE YOLANDA JACKSON. Councilor Tumlin introduced and made a motion for adoption of Resolution No. 2011-68. The motion was seconded by Councilor Currington. There was no discussion. The motion carried by unanimous consent of the council members.
