

**GARDENDALE, ALABAMA
CITY COUNCIL MEETING
AUGUST 6, 2012**

The City Council of the City of Gardendale, Alabama, met in a regular meeting on the 6th day of August, 2012, at 6:00 p.m., at the Gardendale City Hall. Mayor Othell Phillips called the meeting to order. City Clerk Keith Mosley led the Pledge of Allegiance. Ed Spruill from The Lord's Chapel Church delivered the devotional and led the prayer.

MINUTES

The council was presented with a copy of the minutes of the regular council meeting held on July 16, 2012. Councilor Harper made a motion to approve the minutes as presented. The motion was seconded by Councilor Phillips and carried by unanimous consent of the council members.

Mayor Phillips reported that he received a letter from representatives of the Birmingham Linedance Workshop, who recently held a meeting at the Civic Center that was attended by about 160 people, commending the Civic Center staff for their assistance and service.

Councilor Currington made a motion to approve payment of the August 6th bill list, as listed on "Exhibit A," which is attached hereto and made a part of these minutes. The motion was seconded by Councilor Tumlin and carried by unanimous consent of the council members.

Parks & Recreation maintenance superintendent Dale Hyché reported the following: (a) 136 youth have signed up to participate in flag football this year. (b) Work continues on the new park in the Newcastle community. (c) The youth football "Charity Bowl" will be held on August 25. (d) Registration for the fall youth sports has concluded.

Public Works director Jeff Holliyan reported that Public Works employee Marian Booth was injured earlier in the day as he and fellow employee Bryan Parsons were working at the City Center site. He said Marian exited the truck he was driving but accidentally left the truck in drive. The truck struck him and pinned him to the ground. He said the injuries were not serious but could have been much worse if not for Bryan's quick thinking to move the truck off of Marian. He said Marian was taken to the hospital and was released and sent home.

Mayor Phillips asked if anyone was present in the audience representing these properties; there was no reply. Councilor Harper then made a motion to have these two properties mowed and for the cost of the mowing to be assessed as a lien against the properties. The motion was seconded by Councilor Currington. RESOLUTIONS

RESOLUTION NO. 2012-47: TO AUTHORIZE AN AGREEMENT WITH THE ALABAMA DEPARTMENT OF TRANSPORTATION FOR IMPROVEMENTS TO FIELDSTOWN ROAD FROM THOMPSON STREET TO DECATUR HIGHWAY. Mayor Phillips introduced Resolution No. 2012-47. Councilor Currington made a motion for adoption of the resolution. The motion was seconded by Councilor Harper. In response to a question from Councilor Currington about the portion of Fieldstown Road that will be paved under this agreement, Mayor Phillips clarified that under the original plan the portion from Thompson Street to Odum Road would be paved, but under the current revised plan the portion from Thompson Street to Decatur Highway/U.S. Highway 31 would be paved. He added that this project will be funded by an 80/20 grant secured through the Metropolitan Planning Organization. Councilor Currington added that the City will use gas tax funds to pay the twenty percent portion of the cost. There being no more discussion, the motion then carried by unanimous consent of the council members.

RESOLUTION NO. 2012-48: TO AUTHORIZE AN ADDENDUM TO THE SALES AGREEMENT WITH SOUTHERN WINGS SIX, LLC. Mayor Phillips introduced Resolution No. 2012-48. Councilor Currington made a motion for adoption of the resolution. The motion was seconded by Councilor Tumlin. There was no discussion. The motion then carried by unanimous consent of the council members.

RESOLUTION NO. 2012-49: TO APPOINT CHERIE BRAKE TO THE LIBRARY BOARD. Councilor Tumlin introduced and made a motion for adoption of Resolution No. 2012-49. The motion was seconded by Councilor Morris. There was no discussion. The motion then carried by unanimous consent of the council members.

RESOLUTION NO. 2012-50: TO ACCEPT A BID FOR CONSTRUCTION OF A SEWER MAIN EXTENSION AT THE CITY CENTER. Mayor Phillips introduced Resolution No. 2012-50. Councilor Currington made a motion for adoption of the resolution. The motion was seconded by Councilor Harper. Councilor Currington stated that the cost of this project will be paid from proceeds of the temporary 1-cent sales tax that went into effect on January 1, 2011. He said one of the permissible uses of the proceeds of this tax, as enacted by the council, is for construction of infrastructure needs that will serve new economic development projects, and this project meets that specification as well as the spirit of the enabling ordinance. There being no more discussion, the motion then carried by unanimous consent of the council members.

RESOLUTION NO. 2012-51: TO APPOINT ELECTION OFFICERS FOR THE 2012 GARDENDALE MUNICIPAL ELECTIONS AND AUTHORIZE COMPENSATION THEREFOR. Mayor Phillips introduced Resolution No. 2012-51. Councilor Harper made a motion for adoption of the resolution. The motion was seconded by Councilor Tumlin. Councilor Harper asked if someone from the City has contacted the proposed election officers about serving as election officers. City Clerk Keith Mosley replied yes and added that all of them have confirmed that they will serve as election officers. There being no more discussion, the motion then carried by unanimous consent of the council members.

RESOLUTION NO. 2012-52: TO AUTHORIZE AN AGREEMENT WITH ELECTION SYSTEMS & SOFTWARE, INC. Mayor Phillips introduced Resolution No. 2012-52. Councilor Currington made a motion for adoption of the resolution. The motion was seconded by Councilor Harper. There was no discussion. The motion then carried by unanimous consent of the council members.

CITIZENS' COMMUNICATIONS

Alan Hall, executive director of the Greater Gardendale Chamber of Commerce, announced the following upcoming events: (a) The monthly Chamber luncheon will be on Thursday, August 9, at 11:30 a.m. It will be sponsored by Dr. Fox/Gardendale Chiropractic and catered by Kairos Kafe. The guest speakers will be outgoing Jefferson County Board of Education board member Karen Nix and Oscar Mann, who will be taking her position on the board. (b) A planning meeting for the 2013 Relay for Life will be held at the Civic Center on Thursday, August 9, at 6:00 p.m. (c) The Chamber will hold a ribbon-cutting ceremony at Triple D Hobbies on Friday, August 10, at 11:30 a.m. (d) The Chamber will sponsor a meet-and-greet candidates forum on Monday, August 13, at 6:00 p.m. at the Civic Center. Each candidate will have a few minutes to speak, and then after the forum each candidate will be available to meet the public individually.

Mr. Kermit Dooley said some of the audience members are not able to hear the mayor and council members when they are speaking during the council meetings. He asked if Mayor Phillips would ensure that the speaker system is turned on during future council meetings.

Mr. Mark Cornelius, resident of Phillips Drive, noted that Phillips Drive has been re-opened and asked about the status of this road. Mayor Phillips said he would speak to Mr. Cornelius after the council meeting about his question. Mr. Cornelius then asked if speed control devices, such as speed bumps or speed tables, can be installed if the road remains open. He also complained about a couple of lots that are overgrown with weeds. He also complained about garbage that has accumulated at 4898 Phillips Drive, which he said is a vacant rental property. Mayor Phillips said the Inspections department will investigate these complaints.


Mrs. Judy Brown, 1545 Mount Olive Road, complained about a stormwater drainage problem that she said has destroyed a portion of her property. After describing the details of the problem, Mayor Phillips asked Public Works director Jeff Holliyan and Inspections superintendent Robert Ryant to speak with her and check on the situation in more detail.

Mr. William Flippo, 625 Beasley Road, addressed Mayor Phillips to dispute some financial figures that he said were included in Mayor Phillips' automated campaign phone calls. Mayor Phillips disagreed with several statements made by Mr. Flippo.

ADJOURNMENT


