APPROVAL OF MINUTES

The council was presented with a copy of the minutes of the regular council meeting held on January 7, 2013. Councilor Currington made a motion to approve the minutes as presented. The motion was seconded by Councilor Colvert and carried by unanimous consent of the council members.

Councilor Guinn introduced Mary Kate Pendergast, Marketing Director for Jim 'N Nicks Barbeque. Councilor Jerkins introduced and made a motion for adoption of Resolution No. 2013-09. The motion was seconded by Councilor Guinn. There was no discussion. The motion carried by unanimous consent of the council members. Councilor Jerkins stated it was an honor to serve on the Parks and Recreation Board with everyone and looked forward to the next four years on the board.

RESOLUTION NO. 2013-10: TO DECLARE CERTAIN ITEMS AS SURPLUS AND TO AUTHORIZE THEIR DISPOSAL. Councilor Colvert introduced and made a motion for adoption of Resolution No. 2013-10. The motion was seconded by Councilor Currington. The motion carried by unanimous consent of the council members. The motion was seconded by Councilor Currington. There was discussion by Mayor Phillips to change the wording of the resolution to state this promotion was to fill a vacant position. There being no further discussion the motion carried by unanimous consent of the council members. Fire Chief Clint Doss stood and stated that Jason was a valuable asset to the department and he was glad to have him.


ADJOURNMENT
